INDONESIA

GENERAL INFO
<p>Foreign nationals banned from entering or transiting the country. Exempt are foreigners with a Limited Stay Permit and a Permanent Stay Permit, Diplomatic Visa and Service/Official Visa, Diplomatic Stay Permits and Official Stay Permits, humanitarian, air crew, and foreigners who work on National Strategic Projects. The exempt foreigners must provide a health certificate in English issued by the health authority of each country, stayed for 14 days in the territory/country that is free of COVID-19, and a statement approving to be quarantined for 14 days. Pax without a printed medical certificate in English with a negative Coronavirus PCR test result issued at most 7 days before arrival will be subject to medical screening and quarantine for 14 days.</p>

<p><u>BUSINESS FLIGHT RESTRICTIONS</u></p> <ul style="list-style-type: none"> • All flights originating from India are suspended. • Foreign pax will need to quarantine for 5 days. • Crew and pax need to provide a certificate of health and must have embassy issued visas in advance to enter Indonesia. • Visa issuances to Indian nationals and foreigners who lived or went to India in the past 14 days are suspended until further notice. • All Crew and Pax must have valid PCR/Swab Covid 19 test result issued. Test result is valid for 2 days. • Peduli Lindungi mobile application must be activated upon entry • Foreign nationals under below categories can enter Indonesia: <ul style="list-style-type: none"> ○ Passengers with a Temporary Stay Permit (ITAS) or Permanent Stay Permit (ITAP); ○ Passengers with a Diplomatic Stay Permit or Service Stay Permit; ○ Medical aid workers or Food Sustenance Workers for Humanitarian Purposes; ○ Personnel working on strategic national projects. ○ Air or Maritime crews ○ Holders of valid Indonesian Visa with essential travel reason • Technical Refueling and Crew Rest flight are acceptable. All crew must have valid PCR/Swab COVID 19 test prior to arrival even for tech stop, test result is valid for 72 hours.
QUARANTINE REQUIREMENTS
<ul style="list-style-type: none"> • 5 days quarantine for foreign pax along with 2 days negative COVID19 test are required to enter Indonesia. • Once enter Indonesia, pax must also complete health declaration and statement of willingness to be quarantined for 5 days in facilities provided by the Government if requested

AJPM COVID 19 RESTRICTION INFO**CAMBODIA****GENERAL INFO**

Visa on arrival, e-visa, and tourist visas are suspended. All travelers must have a health certificate demonstrating negative COVID-19 status issued within 72 hours of the date of travel. Foreign nationals must also provide proof of health insurance coverage not less than \$50,000 USD. Required deposit of USD 2000 at a designated bank on arrival. Passengers are subject to medical screenings and a 14-day quarantine upon arrival.

CREW AND PASSENGER**BUSINESS FLIGHT RESTRICTIONS**

- Effective on 28.04.2021: All flights from/to India are banned until further notice. Air travellers originating from India, or transiting via India, will not be allowed to enter
- Only Khmer citizen, Diplomat and foreigners holding type E and K visa are allowed to enter. Type E with invitation and sponsor are currently not allowed.
- All inbound flights from Malaysia, Indonesia and Philippines are banned until further notice.
- For pax entry
 - VOA, Visa Exemption Policy, Tourist visa and eVisa suspended until further notice.
 - Visa application shall be processed at the Royal Cambodian Embassies or Consulates.
 - All pax must show result of MOLECULAR PCR SWAB Laboratory test undergone no more than 72 hours before departure.
 - Mandatory Covid19 test will be done on arrival, 14 days quarantine at hotel is mandatory. A second test will be done on the 13th day of quarantine.
 - Insurance Certificate purchased thru Forte Insurance company in Cambodia.
 - Deposit Cash or Credicard upon arrival \$2,000 US
- For crew entry
 - VOA, Visa Exemption policy, Pre-arranged visa available.
 - Covid19 test will be done upon arrival and need to self-isolate until result is out.
- No restriction for Technical refueling except from Philippines, Indonesia, and Malaysia
- Crew rest is acceptable subjected to Covid19 test upon arrival and self-isolation during the stay
- International passengers originating from Philippines, Indonesia, and Malaysia transiting in the Kingdom of Cambodia must stay on board the aircraft and continue their journey to third destination with the same operator's aircraft. Failure to comply will lead to deportation under full responsibility of air operator.

QUARANTINE REQUIREMENTS

- VDPP/PNH (Air crew, Sponsor and Invitation Only)
 - Sokha Hotel Phnom Penh
 - Tian Yi International Hotels
 - Himawary hotel
 - Dara Airport Hotel (air crew only)

 - Not applicable for stay less than 3 days

- All passengers, both Cambodian and foreign nationals, must undergo COVID-19 testing upon arrival. They will be required to remain in the premises until availability of laboratory results.
- The result (in form of a written test certificate) does take up to 24 hours. Shall observe self-isolation at a government accredited hotel or facility until test results become available.
- If one or more travelers is tested positive for COVID-19, other accompanying travelers will

be subject to a 14-day quarantine at a designated Government facility.

- If all travelers are tested negative, they will be allowed to a 14-day self-isolation at their respective home/hotel under supervision of the local authorities and health officials. They will be required to undergo an additional COVID-19 testing, on the 13th day of self-isolation.
- Sponsor and Invitation: Validation Certificate scheme is currently suspended until further notice
- Crew: Shall undergo a COVID-19 laboratory test on arrival. The result (in form of a written test certificate) does take up to 24 hours.
 - VDPP/PNH - Shall observe self-isolation at the DARA airport hotel until test results become available.
 - VDSR/REP - Shall observe self-isolation until test results become available. There is no designated hotel. This is not applicable for stay less than 3 days.
 - VDSV/KOS - Shall observe self-isolation at the Queenco hotel until test results become available.
 - The hotel booking needs to be done by the operator. Transport to/from the hotel will be provided. Payment for the hotel must be made by the crew upon checkout or online while booking. A stay in other hotels, before the test result is out, is not permitted.
 - If the test result is not out at the time of next departure schedule, the crew can depart.

ADDITIONAL INFO

- **#** Non-citizens need to pay USD 2,000 on arrival to cover the cost of self-isolation hotel accommodation and medical expenses.
- All foreign travelers will be required to undergo two COVID-19 tests and shall pay 100 USD for each test. This amount will be deducted from their bank deposit. The Ministry of Health will return the remaining deposit to each passenger in 3 days after the second COVID-19 test shows a negative result.
- Required to purchase a health insurance package for COVID-19 treatment - cost is USD90 and valid for 20 days. This insurance package can be purchased from FORTE Insurance Company at <https://www.forteinsurance.com/covid-19-insurance/>
- This is not applicable to Cambodian Nationals holding passport of the Kingdom of Cambodia or Foreign Passport with Visa K
- Effective on 15.03.2021: Landing permit applications require 5 working days processing

Arrivals of Thai nationals from these three countries are allowed, but they are subject to 21-day mandatory state quarantine, instead of 14. • Effective from 31MAR at 1700Z-30JUN 2021 at 1700Z as below: <ul style="list-style-type: none"> ○ Thais can either present Fit to Fly Health Certificate or Medical Certificate with a laboratory result indicating that Covid-19 is not detected, using RT-PCR method issued within 72 hours before departure from their port of origin to enter Thailand. ○ Non-Thais are no longer required to present Fit to Fly Health Certificate to enter Thailand. They only need to present a Medical Certificate with a laboratory result indicating that Covid-19 is not detected, using RT-PCR method issued within 72 hours before departure from their port of origin. • On 29 April 2021, the Royal Thai government has announced the new regulation elevating the quarantine period to 14 days for all travelers entering Thailand, regardless of nationality and vaccination as follows: <ul style="list-style-type: none"> ○ 1. Travelers who receive a COE before 1 May 2021 will be quarantined as follows: <ul style="list-style-type: none"> ○ 2.1 Those arriving in Thailand between 1 – 5 May 2021 will be quarantined as indicated in the COE (7, 10, or 14 days depending on vaccination record). ○ 2.2 Those arriving in Thailand from 6 May 2021 onwards must be quarantined for no less than 14 days (a new COE may be downloaded at https://coethailand.mfa.go.th/ before departure). • The following aircraft will be allowed to operate at an international airport in the Kingdom when permit is given by the Civil Aviation Authority of Thailand: <ul style="list-style-type: none"> ○ State or military aircraft. ○ Emergency landing flights. ○ Technical landing flights without disembarkation. ○ Humanitarian aid, medical and relief flights. ○ Repatriation flight. ○ Cargo flights. ○ Passenger flights carrying the persons permitted to enter Thailand (11 type). • Permit for passenger aircraft will be subject to approval of Civil Aviation Authority of Thailand for flying over, flying into or out of, and taking off or landing at an international airport in the Kingdom only if the passengers or persons on board are one of the following categories: <ul style="list-style-type: none"> ○ Thai nationals ○ Persons with exemption or persons being considered, permitted, or invited by the Prime Minister, or the head of responsible persons accountable for resolving state of emergency issues to enter the Kingdom, as necessary. Such consideration, permission or invitation may be subject to specified conditions and time limits.

- Non-Thai nationals who are a spouse, parents, or children of a Thai national.
- Non-Thai nationals who hold a valid certificate of residence, or permission to take up residence in the Kingdom
- Non-Thai nationals who hold a valid work permit or are allowed to work in the Kingdom, including their spouse or children.
- Carriers of necessary goods, subject to immediate return after completion.
- Crew members who are required to travel into the Kingdom on a mission and have a specified date and time for return.
- Non-Thai nationals who are students of educational institutions approved by Thai authorities, including the parents or guardians of the students.
- Non-Thai nationals who are in need of medical treatment in Thailand, and their attendants. However, this shall not include medical treatment for COVID-19.
- Individuals in diplomatic missions, consular affairs, international organizations, government representatives, foreign government agencies working in Thailand, or individual in other international agencies as permitted by the Ministry of Foreign Affairs, including their spouse, parents, or children.
- Non-Thai nationals who are permitted to enter the Kingdom under a special arrangement with a foreign country.
- The Center for COVID-19 Situation Administration (CCSA) approved reopening the country's borders to welcome foreign visitors, both short and long term such as the following:
 - Holders of non-immigrant B visa, who are businesspeople (without a work permit or WP3) and are willing to enter Thailand for business purposes.
 - Holders of Special Tourist Visa (STV)
 - Holders of Non-Immigrant OA and OX Visa
 - Requirements:
 - Inbound Passenger (Non-Thai Passengers):
 1. Certificate of the entry (COE) issued by consulate.
 2. Fit to fly certificate.
 3. Covid-19 test with Negative result (PT-PCR / Nasopharyngeal Swab ONLY).
 4. Health insurance with at least \$100k of COVID coverage.
 5. Confirmation for Alternate State Quarantine Hotel (ASQ)

RESTRICTIONS FOR TECHNICAL REFUELING/CREW REST

- No restrictions for technical refueling with no crew disembarkation.
- Crew rest are subjected to approval on case by case basis
- Crew members who are required to travel into Thailand for any missions need to have a specific date and time for return. The approval on a case by case basis, need schedule and purpose of flight to check with the authority
- As of 01 March 2021, passengers are able to transfer at BKK / VTBS airport (both international and domestic transfer) subject to the conditions laid out in the Guidelines for International Flights with Transit/Transfer Passengers at Suvarnabhumi International Airport.
- This includes transfer to/from private jets and other non-scheduled flights. Private jet traffic is currently exceptionally considered for VTBS / BKK but parking for ground time longer than pax drop-off/pick up (or exceeding 12h) might not be available.
- Requirements:
 - Crew for tech stop flight:

- Crew for overnight:

QUARANTINE REQUIREMENTS

- Covid19 test upon arrival, 14 days quarantine at ASQ (Alternate State Quarantine) Hotel.
- Exemption is possible for short duration business visit on case by case basis with local sponsor, subjected to approval from embassy, Ministry of Foreign Affair and health authority. A medical escort will be assigned for such exemption during the whole period in Thailand.
- Process to reserve ASQ:
 - 1. Make room reservations directly to the ASQ hotel, when you know the date of entry to Thailand.
 - 2. Hotel will inform related authorities at the airport and will pick you up from the airport on arrival date/time.
- Please note: Require 5-7 working days lead time to apply slots and Thai Landing permit.

Inbound pax flights not permitted. Exempt are flights carrying diplomats, persons attending important foreign affairs events, experts, business managers, highly skilled workers, and specially approved cases. Outbound pax flights permitted. All pax subject to compulsory 14 day quarantine

Coronavirus (COVID19) RT-PCR test result issued between 3 to 7 days before arrival.
The test must be taken at the laboratory of the authorized medical authority.

- CREW
 - Must make a medical declaration.
 - Must show COVID-19 negative medical certificate issued no more than 72 hours prior to arrival

RESTRICTIONS FOR TECHNICAL REFUELING/CREW REST

- For tech stop for refueling can be operated. (Quick turnaround: No visa required if they depart immediately after passenger drop-off/pick-up.)
- If crew need to enter Vietnam, they hold embassy issued visa in advance or a valid APEC card (with Vietnam listed on the back of the card), they will be allowed entering Vietnam subject to approval from authorities and to the application be submitted at least 02 working days before planned arrival. For this the visa copies and fit to fly certificates need to be submitted. But please note that Vietnam authorities are the sole decision-maker and thus we cannot guarantee your crew will be granted an entry clearance.

ADDITIONAL INFO

- Health Declaration Form must be completed before arrival.
- Quarantine form prior must be completed before arrival.
- To ensure disease prevention, all pax/crew must wear protective suit with face mask upon arrival in Vietnam
- Pax/crew can exit Vietnam under the condition that they have finished 14-day quarantine or having negative Covid-19 RT-PCR test certificate from a test conducted in Vietnam in hand (which normally takes 36-48 hours to be issued).

AJPM COVID 19 RESTRICTION INFO**SINGAPORE****GENERAL INFO**

All foreign travelers will not be allowed to enter or transit with the exception of work pass holders and their dependents, if the work pass holder is providing an essential service. All Singapore citizens/perm residents, and long-term pass holders returning will be quarantined for 14 days at dedicated Stay Home Notice facilities. Each air crew member must complete a health declaration and must remain at the Crowne Plaza Airport Changi, submitting a BAGA Layover Request with prior approval. Air crew operating for aircraft maintenance must also complete the Annex A application. Pax entering Singapore must have a medical cert. with a negative Coronavirus PCR test result issued no more than 72 hrs before departure from the first embarkation point unless exempt.

CREW AND PASSENGER**BUSINESS FLIGHT RESTRICTIONS**

- With effect from 20 May 2021, all arriving passengers on flights from Bangladesh, India, Nepal, Pakistan and Sri Lanka, entering Singapore will need to take both COVID-19 Antigen Rapid Test (ART) and the current COVID-19 Polymerase Chain Reaction (PCR) Test upon arrival at Seletar/Changi Airport. Travelers aged 6 and below (e.g., those born in 2015 to 2021) will be exempted from both tests.
 - Abovementioned passengers will be required to pay for the COVID-19 ART from 27 May 2021, that is in addition to the COVID-19 PCR test that all passengers are required to pay for. The Singapore Government will waive the COVID-19 ART charges until 26 May 2021.
- Brunei has temporarily suspended its reciprocal green lane arrangement with Singapore from 7pm on Thursday (May 20) until further notice.
- PAX:
 - Only Singaporean, Permanent Resident (PR) and Long Term Pass Holders with relevant entry approval (LTPH) are allowed to enter Singapore due to the current pandemic
 - No short term visitor except for listed countries with relevant entry approval in the following link: <https://safetravel.ica.gov.sg/arriving/overview>
 - For pax SHN and Swab requirements, kindly see following summary: <https://safetravel.ica.gov.sg/files/SHN-and-swab-summary.pdf>
- Crew:
 - Foreign air crew, including long-term pass holders with recent travel history (including transit) to Bangladesh, India, Nepal, Pakistan and Sri Lanka within the past 21 days will not be allowed to layover in Singapore.
 - Crew are only allowed to enter Singapore due to the below 4 requirement:
 - Dropping off passenger from Singapore
 - Picking up passenger from Singapore
 - Operating an aircraft into Singapore for maintenance
 - Operating and aircraft out of Singapore after completion of maintenance
 - Crew will need to have entry approval grant from CAAS and application takes minimum of 5 days lead time
 - Crew will need to serve quarantine at dedicated hotel till for next departure flight, please note crew can only stay up to 14 days maximum - subjected to CAAS crew entry approval

RESTRICTIONS FOR TECHNICAL REFUELING/CREW REST

- Technical stop allowed. Rest overnight allowed with prior approval from CAAS.
- For Crew operating SG-SG flights (Turnaround without clearing overseas CIQ) – No SG Arrival Card and SHN required.

- **FOREIGN CREW**
 - As per conditions in CAAS Circular 29, all foreign crew with travel history to any country within the last 14 days – NTL; do not disembark from aircraft.
 - Only with prior approval from CAAS, SHN at Crowne Plaza Changi Airport; Crew layover application will require 05 working days lead time.crew out allowed within 14-day SHN period
 - Only with prior approval from CAAS, pax out allowed upon completion of 14-day SHN; must depart immediately and not to stay in Singapore
 - Only with prior approval from CAAS, Air crew of foreign operators may operate an aircraft into or out of Singapore for maintenance purposes (ANNEX A)
- **LONG-TERM PASS HOLDER CREW**
 - As per conditions in CAAS Circular 29, all foreign crew with travel history to any country within the last 14 days – NTL; do not disembark from aircraft.
 - Only with prior approval from CAAS, SHN at Crowne Plaza only; crew out allowed within 14-day SHN period
 - Only with prior approval from CAAS, pax out allowed upon completion of 14-day SHN; must depart immediately and not to stay in Singapore
 - Only with prior approval from CAAS, Air crew of foreign operators may operate an aircraft into or out of Singapore for maintenance purposes (ANNEX A).
 - Only with prior approval from Ministry of Manpower (MOM), crew can enter Singapore with intention to stay beyond 14-day SHN period (ie. Return to residence after 14-day SHN at dedicated SHN facilities or no departure schedule within 14-day SHN)
- **SINGAPORE CITIZEN/PERMANENT RESIDENT CREW**
 - For crew with departure schedule within 14 days, SHN at at Holiday In Express Katong or Hotel Indigo Singapore Katong. Crew out within 14-day SHN period allowed. (Swab test before crewing out is not required)
 - For returning crew without departure schedule, crew will be required to serve full 14-days SHN at Crowne Plaza. All persons completing their SHN will be subject to a swab test before the end of the SHN.

QUARANTINE REQUIREMENTS

- For Singapore citizens and permanent residents:
 1. Travel history within the last 14 days from Australia, Brunei, Mainland China, New Zealand, Taiwan
 - No pre-departure test required
 - COVID-19 PCR test on-arrival, with self-isolation at self-sourced accommodation or own place of residence, until test results are released to traveler.
 2. Travel history within the last 14 days from Macao and Hong Kong
 - No pre-departure test required
 - COVID-19 PCR test on-arrival
 - 7-day SHN at self-sourced accommodation, including place of residence and COVID-19 PCR test at the end of SHN
 3. Travel history within the last 14 days from Fiji, Sri Lanka, Thailand, Vietnam
 - No pre-departure test required
 - COVID-19 PCR test on-arrival 14-day SHN at SHN Dedicated Facility (SDF) and COVID-19 PCR test at the end of SHN
 4. Travel history within the last 14 days from UK and South Africa
 - No pre-departure test required
 - COVID-19 PCR test on-arrival*
 - 14-day SHN at SHN Dedicated Facility (SDF) and an additional 7- day SHN at place of residence, with COVID-19 PCR test at the end of each SHN

ADDITIONAL INFO

- If pax wish to visit business offices during their trip, they can get the Singaporean business partner to apply for a pre-approved business pass with the Ministry of Trade and Industry. Visitors on said pass will be tested on arrival and must quarantine until negative results are obtained. Other conditions vary as each pass is issued on a case-by-case basis.
- Alternatively, if they are traveling to meet with business partners and the meetings do not need to be held on-location, they can opt for the new Connect@Singapore scheme. Please see <https://safetravel.ica.gov.sg/connectsg/overview> for more details.
- All entry/layover approval will require supporting documents (such as maintenance log, departure itinerary, letter of commitment, Annex A etc) and minimum 72 hours processing time by CAAS.
- All travellers entering Singapore, including Singapore Citizens, Permanent Residents and Long-Term Pass (LTP)/ In-Principle Approval (IPA) holders, must submit a health declaration prior to the flight. They will have to do so via the SG Arrival Card (SGAC) e-Service, or the mobile application that can be downloaded for free from Apple AppStore and Google Play. Singapore will require a copy of the acknowledgement form 3 hours prior to departure from point of origin.
- In line with the calibrated reopening of Singapore's borders, ICA will lift visa suspension and resume the issuance of new visas. Short-term visitors who require a visa to enter Singapore can apply for visas through a local contact, Singapore overseas mission, or authorised visa agent from 18 October 2020, 2359 hours. Visitors who had already been issued with visas which are still valid, as well as those who are eligible for the visa-free transit facility, do not need to re-apply/ apply.
- Possession of a valid visa alone does not guarantee entry into Singapore. All short-term visitors must still seek prior approval via appropriate COVID-19 travel channels (e.g. obtain a Safe Travel Pass under Green/Fast Lane arrangements, or Air Travel Pass) before they can enter Singapore. More information will be available at ICA's website (<https://www.ica.gov.sg/covid-19>).
- With effect from 31 January 2021, 2359 hours, visitors applying to enter Singapore under the ATP and RGLs will need to have travel insurance for their COVID-19-related medical treatment and hospitalisation costs in Singapore, with a minimum coverage of S\$30,000. The travel insurance will help them pay for the costs of their medical treatment in Singapore. The visitors can purchase the travel insurance from Singapore-based or overseas insurers. A completed "Case Investigation Form" must be presented upon arrival

Business flights are currently not allowed, but may allow to operate if they can request for exemption from Department of Foreign Affairs/ IATF.

ACTION TO BE TAKEN BY TRAVELLERS:

- i) All travellers are required to install, activate, and register the *MySejahtera* application (<https://mysejahtera.malaysia.gov.my/>) in a mobile phone before arrival in Malaysia;
- ii) Undergo COVID-19 test with negative result three (3) days prior to departure;
- iii) Using MySejahtera application to registered QR Code on arrival at Point of Entry (PoE);
- iv) Screening for fever and symptoms at PoE;
- v) Subjected to mandatory quarantine for 14 days at designated quarantine station;
- vi) Monitoring health status using MySejahtera application for 14 days during the quarantine period. If symptoms develop during the quarantine period, inform the medical team for further management;
- vii) Make sure to stay in the room at QS;
- viii) Follow the SOP, legislation, and regulation relating to COVID-19 management which has been prescribed by the government at all times;
- ix) Undergo the COVID-19 screening test on the 10th day from the date of arrival in Malaysia;
- x) Travellers will be given a release order on day 14 if the result of the COVID-19 test is negative. Undergoing the COVID-19 screening test on the 10th day from the date of arrival in Malaysia
